Cesvi approach is focused on generating a real impact on beneficiaries.

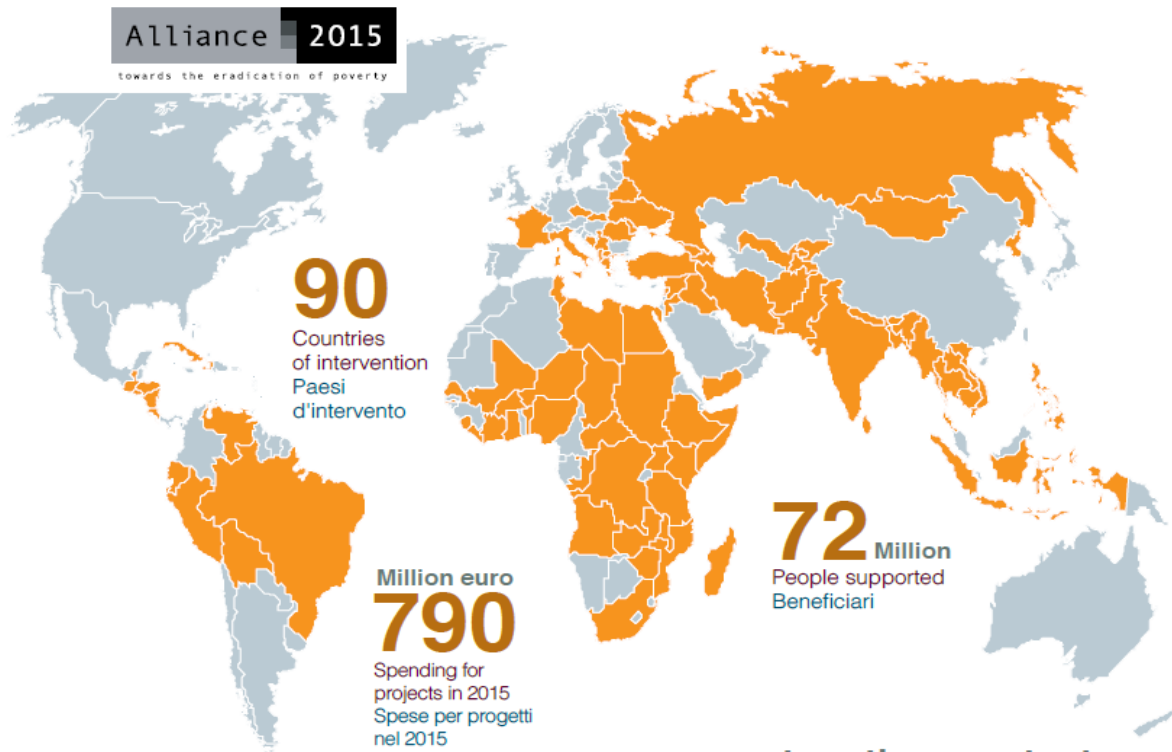

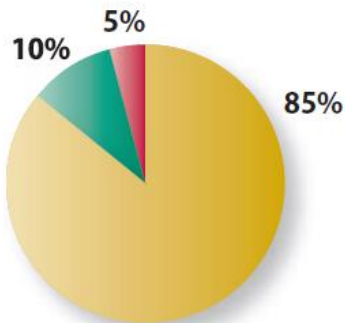
TRASPARENCY AND EFFICIENCY

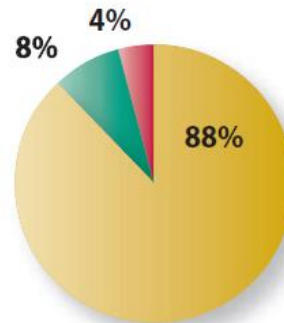

EFFICIENCY INDEX | INDICE DI EFFICIENZA DELL'ORGANIZZAZIONE

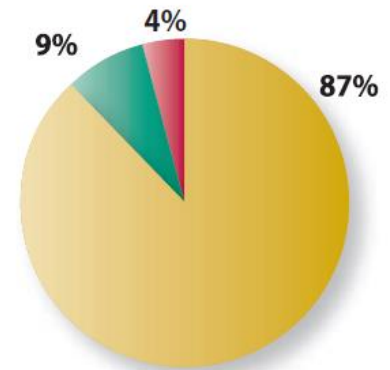

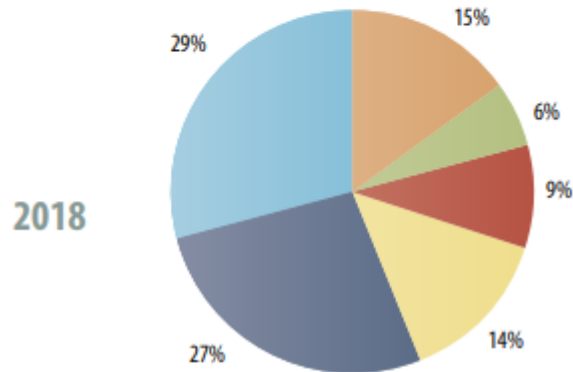

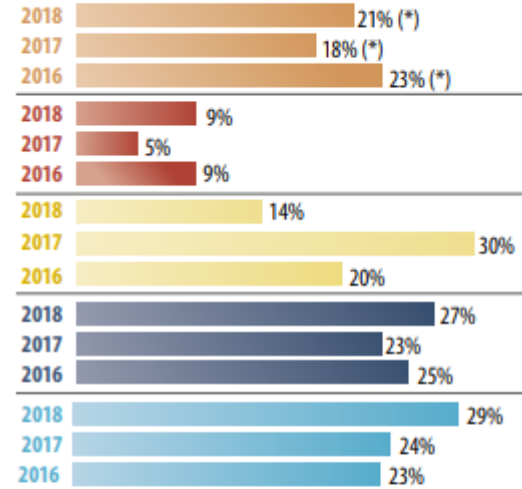

Cesvi Legal and Compliance Department is in charge of the fulfillment of all rules, regulations, requirements and standards while implementing all organizational activities.

CESVI VALUE SYSTEM AND COMPLIANCE

2018: ORGANIZATIONAL DEVELOPMENTS

In 2018, Cesvi adopted an **Ethical Code** applying to everyone in any way involved with the Foundation's activity. Cesvi and all its stakeholders shall act in respect of the fundamental human rights avoiding in their relations with counterparts any discrimination based on age, gender, sexual orientation, state of health, race, nationality, political leanings and religious beliefs.

At the same time Cesvi adopted a new **Model of Organization and Management in compliance with Italian Law 231/2001**, which encouraged the updating of organizational, thematic and management policies.

Cesvi updated and created new tools and documents to fulfil all principles related to the **GDPR - General Data Protection Regulation** and nominated as Data Protection Officer (DPO) a dedicated consultant .

2018: ORGANIZATIONAL DEVELOPMENTS

In 2018, Cesvi released also:

- ✓ a new version of the **Prevention of Corruption and Fraud Policy**, which embrace all international requirements and standards and defines guidelines and mandatory rules for all activities performed in Italy or abroad.
- ✓ **PSEA Policy** - Protection from Sexual Exploitation and Abuse Policy, which defines the highest standards of personal and professional conduct at all times to protect above all, beneficiaries of humanitarian assistance. SEA are a violation of Cesvi Ethical Code and Cesvi Code of Conduct.
- ✓ **Child safeguarding policy** - As organization working or in contact with children, Cesvi has the responsibility to make sure that its staff, operations, programmes do no harm to children, and that they do not expose them to the risk of harm and abuse.

Cesvi next challenges from a Legal and Compliance perspective:

- In Italy: the fulfillment of all requirements and challenges set by the Third Sector reforms, according to Italian Law.
- Abroad: the registration of legal entities and/or branches in new Countries of operations and the fulfillment of applicable national rules and laws
- Worldwide: the development of models for Social business and for private partnerships
